

Dear Miss Mathias: -

At the time your letter of January 16th was received we were trying to work out some scheme by which certain modifications could be made in reference to the publication of parts of the North American Flora. I am very sorry that I did not at that time note the last paragraph in your letter as I should very much like to have an opportunity of discussing the matter of work on the Umbelliferae with you. The situation with which we are faced is, that the Umbelliferae comes at the very end of a proposed volume and nothing has been done on any of the preceding families in this particular volume. It is, of course, desirable that an Digitizent. Barnhart and mysell have given considerable attention to the ation matter and we have worked out a tentative plan of issuing separately paged parts of individual volumes in those cases where nothing intended to be included in a particular volume has as yet been published. I think this scheme is a practicable one and it would enable us to proceed more rapidly with publication in the future than has been the case in the past, provided arrangements can be made for the actual preparation of the manuscript covering the individual families. I think you will agree with me that it is highly desirable, wherever possible, to take advantage of the accumulated knowledge of specialists in individual groups.

> Unfortunately, this institution, like others of its kind, is handicapped at the present time because of insufficient funds and I do not see any immediate possibility of adding to our staff just now. An ideal arrangement, perhaps, might be an appointment covering a reasonable period of time that would enable a specialist to work either at The New York Botanical Garden or elsewhere on the preparation of the manuscript covering an individual family. It is possible that some scheme like this may be consummated in the future, but there seems to be no immediate prospect of funds being made available for this specific purpose. The best that I could possibly do at the present time would be to give you a scholarship appointment for a limited period on a very nominal salary, and I doubt very much whether anything I could offer would be satisfactory to you. Still, there is a possibility that something mutually satisfactory could be arranged that would enable you to go ahead on the actual preparation of the manuscript covering the Umbelliferae of North America.

It is, of course, not essential that the work be done at any particular place, presumably much of it could be done at Pittsburg, although at times you should of course have the opportunity of consulting essential literature that probably is not available there. Some literature can be provided, perhaps on loan or perhaps by copying certain descriptions and other data of this kind. The New York Botanical Garden makes institutional loans of its herbarium material and I feel that there would be no difficulties in the case of the Umbelliferae as no one is at present working on our material representing this family. I feel certain that satisfactory arrangements could be made to borrow material from other institutions for your use.

If you have any definite suggestions to offer I wish that you would communicate with me. I know that Dr. Britton is very keenly interested in the progress of the North American Flora, as the work was initiated under his leadership and in spite of existing economic conditions I would personally like to see the work expedited. Fortunately, when it comes to the matter of publication we can handle the situation because the North American Flora, as to the actual cost of printing, is self-supporting.

Dear Dr. Mathias:

Referring to our previous correspondence, can you give me any idea as to how long it would take you to prepare the manuscript covering the Umbelliferae for North America for publication in the North American Flora, provided some financial assistance could be granted to you by The New York Botanical Garden? I have a limited amount of money from a restricted fund that can be used for the purpose indicated. From this fund a very nominal salary of \$75.00 a month was paid to Mr. Core during the time that he spent at New York on a study of the American species of Scleria. If this relatively little financial assistance would enable you to go ahead on the project, I would be very glad to consider giving you an appointment for a mumber of months, if you are in a position to go ahead with the work. I can safely guarantee the continuation for at least a period of six months; just how much longer the stipend could be continued I do not know, because of existing economic conditions. This would not mean that you would of necessity have to come to New York but could do a great part of your work in Pittsburgh, although doubtless you would like to arrange to make a trip to New York to segregate material that you may need for study and to make arrangements for borrowing material from other institutions, such as the Mational Herbarium, Gray Herbarium, Missouri Botanical Carden, and the Field Museum.

> I only wish that I had more ample restricted funds that could be used for financing the preparation of the treatment of various families for the North American Flora, but, unfortunately, this is not the case. I may state that it has been our policy to pay \$2.00 per printed page to individual authors other than those officially connected with The New York Botanical Garden. Your case is somewhat different from any other one that has been handled, in that no other collaborator has received any compensation from The New York Botanical Garden in connection with the preparation of manuscripts for the North American Flora other than the page rate mentioned above.

If you should happen to be in or near New York at any time within the next few months, I wish that you would take advantage Dr. Mildred Mathias

The order is a rather large one and it will naturally take some time to search for the descriptions in the library and then have them copied. > Dr. Barnhart informs me that pre-Linnean synonyms are not cited in the North American Flora, but good pre-Linnean illustrations are occasionally cited. As far as I am concerned, I am willing to leave this entirely to your judgment.

I am having a rubber stamp forwarded to you for stamping our sheets after you have actually examined them. This stamp, "Examined for North American Flora", should be used on or near the label. I would very greatly prefer if you would use a pad with black, if possible, indelible ink rather than a colored aniline as the latter tends to fade badly.

Mr. Wilson is segregating the Sanicula and Eryngium material and as soon as the specimens are packed they will go forward to you by freight or express.




